Sub: - Clarification – reg.

WHEREAS, PAWANRAJA WOMENS COLLEGE OF EDUCATION (B.ED.), GRAM VIKAS SANSTHA, CHUTE RANGMANDIR, TEKADI SHALA, AT PAUNI, TEH. PAUNI, DIST. BHANDARA-441910, MAHARASHTRA had applied in the office of WRC on 29.12.2006 for seeking recognition for starting B.ED. (GIRLS) course under Section 14 of the NCTE Act, 1993.

AND WHEREAS, the inspection of the said institution was conducted by the visiting team on 04.07.2008.

AND WHEREAS, in its 105th meeting held on August 11-12, 2008, the Western Regional Committee after considering the report of the visiting team, perusal of videography as well as other relevant materials furnished by the applicant institution, was satisfied that the applicant institution does not fulfill the requirements and issued a notice on 02.09.2008 to the applicant institution under proviso to Section 14 (3) (b) of the NCTE Act, 1993, thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.

- Existing building area is less as per NCTE norms.
- Land documents not as per NCTE norms.
- Building is not completed (building is only for three year lease).
- Teaching staff not qualified as per NCTE norms.
- CLU from the competent authority not submitted.

AND WHEREAS, the applicant institution had submitted representation dated 30.09.2008 to WRC, NCTE. The said representation of the institution was considered by the Western Regional Committee in its 109th meeting held on October 19-20, 2008, and issued letter to the institution u/s 7(9) of NCTE Regulations, 2007 on 05.11.2008.

AND WHEREAS, WRC considered the case of the institution in light of letters F.No.49-27/2007/NCTE(N&S)Part/87096 dated 21.11.2008 received from Member Secretary, NCTE, New Delhi and negative recommendation received from Maharashtra State Government in respect of B.Ed. Course. Keeping in view of the negative recommendation received from the Maharashtra State Government in respect of B.Ed. course and directions received from NCTE Hqs, the WRC decided that no further processing will be done in this case and communication to this effect to be made to this institution. Accordingly, the application was closed vide order No.WRC/APW05071/123626(GIRLS)/2009/53997 dated 14.04.2009.


AND WHEREAS, the institution had preferred an appeal dated 27.05.2009 before the Council (NCTE) under section 18 of NCTE Act, 1993 against the above referred order issued by WRC. The Council vide order No. 89-380/2009-Appeal-99643 dated 07.08.2009 rejected the appeal and WRC's order dated 14.04.2009 was confirmed.

AND WHEREAS, the institution vide letter dated 16.12.2009 has requested to reconsider the application, in light of court order dated 01.12.2009 passed by Hon'ble High Court Bombay, at Nagpur Bench, in Writ Petition No.4709 of 2009.

AND WHEREAS, in compliance of direction passed by Hon'ble High Court of Bombay vide court order dated 01.12.2009 in Writ Petition No.4709 of 2009, the application was considered by WRC in its 137th WRC meeting held on June 14, 2010, and WRC decided that clarification on the following points be sought from the institution:-

- *Certified copy of registered land documents be submitted.*
- *List of the duly qualified and approved list as per Regulations 2009 be submitted.*

NOW THEREFORE, in exercise of the powers vested to the Western Regional Committee under section 14 of NCTE, Act. 1993, an opportunity is hereby given to the said institution to submit the above mentioned documents in the office of WRC within three months for taking action in the matter.
