The 156th meeting of WRC was held on November 11-12, 2011.




1. Directions of WRC for processing of applications:

1. The applications should be processed chronologically on first come first serve basis. *not being*
2. Any technical objections like requisite number of copies, a little delay in reply, and DD from Nationalized Bank should be dealt at the Regional Director's level.
3. On-line applications should be processed as per check list prepared by the WRC, and the applicants should be clearly advised, the land ownership, change of land use, and building plan and encumbrance certificates should be submitted as originally certified/notarized copies from the competent revenue authorities. The correct designation of the competent revenue authority be also advised.
4. Also that the undertaking and affidavit are needed on original stamp paper.
